ANNEX 1

Below is an extract of information provided by IFRA in relation to types of application present in each IFRA Category. Additional information about IFRA Categories can be found in the Guidance to IFRA Standards, issued by IFRA.

IFRA Category	Product Type
IFRA Category 1	Products applied to the lips (all types): Lip products e.g. lipstick, lip balm; Childrens toys
IFRA Category 2	Products applied to the axillae: Deodorant and antiperspirant products of all types (including any product with reasonably foreseable use on the axillae or labelled as such) e.g. spray, stick, roll-on,under-arm, deo-cologne etc; Body sprays/mists
IFRA Category 3	Products applied to the face/body using fingertips: Eye products e.g. eye make-up, eye masks, eye pillow, eye moisturizer; Facial make-up and foundation; Make-up remover; Nose pore strips; Wipes for face, neck, hands, body; Facial masks; Body and face paint (for children and adults)

IFRA Category 9	Products with body and hand exposure, primarily rinse off: Bar soap; Liquid soap; Shampoo of all type; Conditioner (rinse-off); Body washes and shower gels of all types; Baby wash, bath, shampoo; Bath gels, foams, mousses, salts, oils and other products added to bathwater; Cleanser for face (rinse-off); Shaving creams of all types e.g. stick, gels, foams; All depilatories (including facial) and waxes for mechanical hair removal; Foot care products (feet are placed in a bath for soaking); Shampoos for pets

IFRA Category 12	Products not intended for direct skin contact, minimal or insignificant transfer to skin: Candles of all types; Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods); Automated air fresheners and fragrancing of all types e.g. concentrated aerosol with metered doses, plugins, electrical, incense, liquid refills (cartridge); Air delivery systems; Cat litter; Cell phone cases; Deodorizers/maskers not intended for skin contact e.g. fabric drying machine deodorizers, carpet powders; Fuels; Insecticides e.g. mosquito coil, paper, electrical, fragrancing sachets, for clothing, excluding aerosols/sprays; Joss sticks or incense sticks; Dishwash detergent and deodorizers - for machine wash; Olfactive board games; Paints; Plastic articles (excluding toys); Scratch and sniff; Scent pack; Scent delivery system (using dry air technology); Shoe polishes; Rim blocks (Toilet)
